SUICIDE THEORY SCOUTED

Girl's Mother Finds Bodies—Parents of Man, Separated for Years,

Meet Beside Son's Coffin.

CUMBERLAND, Md., Jan. 1.—That Grace Elosser and her fiance. Charles E. Twigg, died of cyanide poisoning was established to-day, by chemical analyses of the stomachs of the dead girl and man. Further than this, little or no light has been thrown on the mystery of the deaths of the two, whose bodies were found by the mother of the girl, seated upon a sofa in the parlor of the Elosser home yesterday.

The theory of a double suicide is de-

clared impossible by the family and friends of Miss Elosser, and also by those who knew Twigg. The two were to have been married to-night. The authorities are working upon the theory that murder may have been committed.

Coroner Beall states that half an hour elapsed between the time of the discov-

ery of the bodies and the summoning of a physician or the notification of any one outside of the Elosser family. The remainder of a box of cand- and some chewing gum found in the Elosser home will be examined for traces of the poison. but as all the other members of the dead girl's family ate from the box of candy without ill-consequences, little is expected from this. The tips of the tongues of the two victims of the tragedy showed flammation, as if they had been bitten, and it is said to have been evident that larger quantity of Twigg took a poisen than did Miss Elosser. Notle or other receptacle that could have contained the cyanide has yet been found.
The body of Miss Eiosser lies at her home, dressed in the gown in which she was to have been married to-night. Twigg's body was removed this after-

noon to his home at Keyser, West Va. His father and mother, who have been separated for several years, met to-day beside their son's coffin.
